REGISTRATION

TERMS & CONDITIONS

1. In-person and online registration

Intergraf Currency+Identity is open exclusively to security printers, suppliers to security printers, central banks, government authorities, law enforcement, and industry-specific digital solution providers. All participants have submitted detailed documentation and product samples to enable Intergraf's Committee of Experts to assess their eligibility. Intergraf reserves the right to refuse participation if the required criteria are not met.

2. Payment

Payment is due upon receipt of the invoice and must be made in euro. Any sum unpaid within 30 days of the invoicing date shall automatically and without notice attract interest at a rate of 1.50% per month. Payment can only be made by bank transfer or credit card (Visa, MasterCard and American Express). No payment can be taken onsite.

3. Cancellation

If you registered in-person and are not able to attend because of imposed travel bans or quarantine restrictions that were not known at the time of registration, your in-person registration will automatically be turned into an online registration.

If you wish to completely cancel your in-person or online registration, the following policy will be applied by Intergraf:

- cancellations made after 16/01/2022 will incur a charge of 50% of the total invoiced fees

- cancellations made after 01/03/2022 will incur a charge of 100% of the total invoiced fees

- refunds will not be given for no-shows.

4. Substitutions

If you registered and can no longer attend, another representative from your company can take your place at no extra charge, provided that you notify us in writing before 21/03/2022 at intergrafconference@intergraf.eu.

5. Insurance and liability

Registration fees do not include insurance of any kind. In-person participants carry their own risk for personal injury or loss of property, including baggage, during the conference. Intergraf is in no way responsible for any insurance claims.

6. Privacy

Personal data collected during registration is used to keep contacts informed about current and future events. Contacts can opt in or out
