# REGISTRATION

## TERMS & CONDITIONS

### 1. Registration

Intergraf Currency High is strictly restricted to printers using intaglio, currency issuing authorities, government authorities and law enforcement.

Intergraf Identity High is strictly restricted to printers of passports in circulation, identity document issuing authorities, government agencies and law enforcement.

Intergraf reserves the right to refuse participation if the required criteria are not met.

### 2. Payment

Payment is due upon receipt of the invoice and must be made in euro. Any sum unpaid within 14 days of the invoicing date shall automatically and without notice attract interest at a rate of 1.50% per month.

Payment can only be made by bank transfer or credit card (Visa, MasterCard and American Express) and no later than 13/10/2023. No payment can be taken onsite.

### 3. Cancellation

If you wish to cancel your registration, the following policy will be applied by Intergraf:

- cancellations up to 27/07/2023 will be refunded
- cancellations from 28/07/2023 will incur a charge of 25% of the total invoiced fees
- cancellations from 28/09/2023 will incur a charge of 100% of the total invoiced fees
- no-shows are non-refundable.

### 4. Substitutions

If you have registered and can no longer attend, another representative from your company can take your place at no extra charge, provided that you notify us in writing before 28/09/2023 at [intergrafconference@intergraf.eu](mailto:intergrafconference@intergraf.eu).
